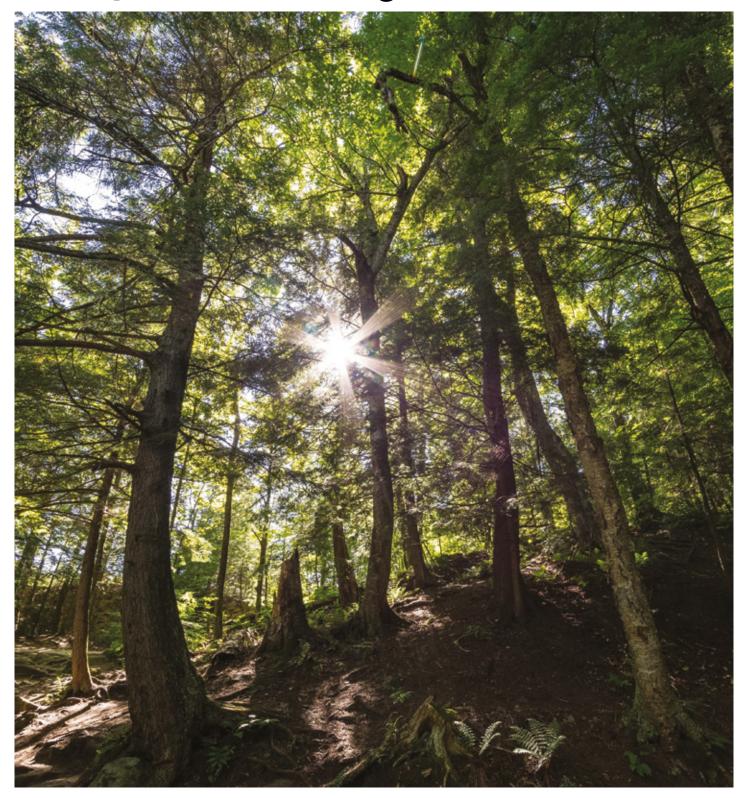

# Safety & Risk Manager

# Job purpose

The Safety & Risk Manager will support Durrell teams across the world to maintain safe and secure working environments for staff, students, volunteers and visitors. The post holder will be responsible for assisting managers to implement Durrell's health and safety policies and procedures, monitoring safety performance, assessing risk and proposing solutions, and encouraging a positive safety culture across the organisation.

This role will be based in Jersey but will provide support across the Trust and as such will require occasional travel to the UK and Durrell's international Field Programmes. The post will be based at Durrell's headquarters in Jersey Zoo and will comprise a mix of desk-based work and working directly with staff across the site.

### Key responsibilities

- Act as the competent advisor on health and safety matters, monitoring developments in the field locally
  and internationally in order to provide expert advice and information to the Trust.
- Supporting management and staff at all levels to develop and review departmental risk assessments and safe systems of work, including providing assistance with identifying solutions to workplace risks that are raised.
- Supporting management to develop and review emergency procedures and participating in drills including fire and animal escape.
- Undertaking workplace inspections and supporting individuals to complete arising actions.
- Coordination of Durrell's Safety & Risk Organisational Groups.
- Promoting a positive incident reporting culture and assisting with incident investigation, root cause analysis and recommending improvements.
- Overseeing training needs analysis, alongside development and delivery of health and safety training in both e-learning and face to face formats.
- Supporting departments based on site at Jersey Zoo with contractor management and statutory inspections.
- Supporting Field Programmes to ensure delivery and compliance with grants and donor obligations.
- Building and maintaining excellent working relationships with Durrell staff and volunteers, as well as with existing partners and other external stakeholders.
- Production of quarterly reports and internal/external comms pieces as required.
- Development and review of content on Durrell's internal Safety, Risk and Safeguarding intranet site.
- Oversight of safety and risk budget lines.
- Promotion of a positive organisational safety culture.

# Knowledge, skill and ability

- NEBOSH Level 6 Dip or equivalent working towards or holding.
- Demonstrated knowledge of UK and European legislation and guidance is essential with knowledge of international legislation and guidance desirable. Direct experience dealing with regulatory agencies and/or compliance officers is preferred.
- Experience of health and safety practice in a multi-site setting, preferably with international experience.
- Experience in developing and implementing health and safety related policies and procedures.
- Experience in developing and delivering training.
- First aid/mental health first aid instructor qualification or willingness to work towards certification.
- Strong administrative and organisational skills and an attention to detail.
- Excellent communications skills with proven ability to engage with multiple stakeholders, with competing priorities.
- Ability to work independently and with remote team members in UK and elsewhere.
- A working knowledge of UK safeguarding best practice would be desirable.
- Proficiency in Microsoft packages Sharepoint, Teams, Excel etc.
- Current driving license
- Proficiency to communicate in French would be desirable.

- Passionate about conservation and an understanding of and commitment to Durrell's vision, mission and aims.
- A positive outlook and 'can do' attitude are vital, showing resilience and creativity in problem-solving.
